This document (which expression shall include all documents incorporated by reference herein) has been prepared for the purpose of providing disclosure information with regard to the 2029 Notes and the 2026 Notes (together, the "Notes") issued by HSBC Holdings plc (the "Issuer") and has been approved by the United Kingdom ("UK") Financial Conduct Authority (the "FCA") as a prospectus (the "Prospectus") for the purposes of Regulation (EU) 2017/1129 as it forms part of domestic law by virtue of the European Union (Withdrawal Act 2018), as amended (the "EUWA") (the "UK Prospectus Regulation").

The Notes will be issued under the Issuer's Debt Issuance Programme (the "Programme").

AN INVESTMENT IN THE NOTES INVOLVES CERTAIN RISKS. INVESTORS SHOULD CONSIDER CAREFULLY THE RISK FACTORS SET FORTH OR REFERRED TO IN THE SECTION HEADED "RISK FACTORS" BELOW.

The Issuer may redeem the 2029 Notes at any time during the period from and including 24 March 2022 to but excluding 24 September 2028 in whole or in part, at a redemption price equal to the Make Whole Redemption Amount (as defined below) and may redeem the 2029 Notes or the 2026 Notes in whole but not in part on 24 September 2028 (in the case of the 2029 Notes) or on 24 September 2025 (in the case of the 2026 Notes) at a redemption price equal to 100 per cent. of their aggregate principal amount (in each case, together with interest accrued and unpaid thereon, if any, to the date fixed for redemption) as further described in Condition 6(c) (*Redemption and Purchase; Substitution or Variation - Redemption at the Option of the Issuer*) of the "Terms and Conditions of the Notes" section of the Base Prospectus incorporated by reference herein and in the sections entitled "Terms and Conditions of the 2029 Notes" and "Terms and Conditions of the 2026 Notes" below. The Issuer may also redeem the Notes for certain taxation or loss absorption disqualification event reasons, as further described in the "Terms and Conditions of the Notes" section of the Base Prospectus incorporated by reference herein and in the sections entitled "Terms and Conditions of the 2029 Notes" and "Terms and Conditions of the 2026 Notes" below.

Applications will be made to admit the Notes to listing on the Official List of the FCA (in its capacity as competent authority for the purposes of Part VI of the Financial Services and Markets Act 2000 as amended (the "FSMA")) and to trading on the main market (the "Main Market") of the London Stock Exchange plc (the "London Stock Exchange"). The Main Market is a UK regulated market for the purposes of Article 2(1)(13A) of Regulation (EU) No 600/2014 as it forms part of domestic law by virtue of the EUWA (the "UK MiFIR"). The FCA has only approved this Prospectus as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation Rules sourcebook in the FCA Handbook. Such an approval should not be considered as an endorsement of the Issuer nor as an endorsement of the quality of the Notes that are the subject of this Prospectus. Investors should make their own assessment as to the suitability of investing in the Notes.

The Notes have not been and will not be registered under the United States Securities Act of 1933, as amended (the "Securities Act"), or the state securities laws of any state of the United States, and may not be offered or sold within the United States or to, or for the account or benefit of, U.S. persons as defined in Regulation S under the Securities Act ("Regulation S") except pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the Securities Act.

The Notes are in bearer form and are subject to U.S. tax law requirements.

The Notes are not deposit liabilities of the Issuer and are not covered by the United Kingdom Financial Services Compensation Scheme or insured by the U.S. Federal Deposit Insurance Corporation or any other governmental agency of the United Kingdom, the United States or any other jurisdiction.

The Notes are expected to be rated with the following long-term credit ratings: A- by S&P Global Ratings UK Limited ("S&P"); A3 by Moody's Investors Service Limited ("Moody's"); and A+ by Fitch Ratings Limited ("Fitch"). Each of S&P, Moody's and Fitch is established in the United Kingdom and registered under Regulation (EU) No 1060/2009 on

credit rating agencies as it forms part of domestic law by virtue of the EUWA. As such, each of S&P, Moody's and Fitch appears on the latest update of the list of registered credit rating agencies (as of the date of this Prospectus) on the UK FCA's Financial Services Register. The ratings each of S&P, Moody's and Fitch have given to the Issuer are endorsed by S&P Global Ratings Europe Limited, Moody's Deutschland GmbH and Fitch Ratings Ireland Limited respectively, each of which is established in the European Union and registered under Regulation (EU) No 1060/2009 on credit rating agencies. **A security rating is not a recommendation to buy, sell or hold securities and may be subject to suspension, change or withdrawal at any time by the assigning rating agency.**

RISK FACTORS

Any investment in the Notes is subject to a number of risks.
